

#### What's Brewing?

#### Recruitment

The recruitment process for a pub manager has begun, details can be found on the website. Other staff will also be required and job descriptions will follow later.

### The Shop

Volunteers will be running an 'essentials' shop which will stock a basic range of items that we find ourselves short of all too often! Stock will include milk, tinned goods, sweets, crisps, eggs & more. A order & collect service from a local butchers is also being considered.

The shop will also house the coffee/tea room. There will also be a village notice board and a display unit giving local people an opportunity to sell their homemade arts & crafts.

## More news... In the Spotlight



Since we made the announcement last month, that we had raised enough to buy The Dog Inn to run as a community freehouse, there has been a lot of attention from the media.

From local radio to the Evening Telegraph, they all want our amazing story of how we are set to become the first cooperative pub in Lancashire!

Vicky Grimes from ITV was the most recent visitor on 17th June. Stan Ainsworth (Ribble Valley Luxury Homes Ltd) was the first to be interviewed, about how he had agreed to sell the pub to the community.

They then questioned board member Kathryn Sharpe who first had the vision of a Community Freehouse back in January, starting the whole project off with an e-mail to villagers. Vicky then sought soundbites from shareholders, explaining the share offer with chalkboard aid from George Hollings (age 5)!

## Dog Inn Makeover

Our aim is to open the doors to the bar & shop areas as soon as possible.

However, we plan to carry out some essential refurbishment and redecoration first.

Whilst we aim to brighten up and modernise The Dog Inn, the refurbishments will be in sympathy with the original features. A lot of the cosmetic decoration of recent decades will be replaced or painted.

Original features such as the large wood beams, stone flag floor, stone walls and the fireplace surround will be restored and enhanced. We are a country pub and that is the look we want to achieve.
