# 9. BLACKBURN WITH DARWEN'S LOCAL PLAN - PROPOSED INDUSTRIAL UNITS ON GREEN BELT UPDATE

Lesley updated the meeting on progress and fundraising needed to raise money for the second payment to the CPRE consultant who has been commissioned to help fight our cause.

Marianne advised of an e-mail received and circulated to the committee from County Councillor Peter Britcliffe, newly elected Chair of LCC Conservative party, and Deputy Chair of Hyndburn's Conservatives, advising us that he had urged Hyndburn Council, at a recent meeting, to object to Blackburn with Darwen's proposal to release land from our Green Belt.

#### 10. JENNIE COOK'S ABUSIVE DOG INN CUSTOMER

Marianne had circulated Jennie's e-mailed complaint about an incident involving a villager verbally abusing her in a loud and aggressive manner because he had been blocked from Facebook some months ago for his abusive comments regarding a village issue. She was volunteering in the coffee shop at the time and was very upset by his language and attitude.

Her situation was discussed and everyone agreed that Jennie has a very difficult role in administering the village web pages especially dealing with some people who post negative, upsetting and unsuitable comments. Banning him from the pub was a harsh move but would be considered if any such incidents happen again whilst Jennie was working in the pub.

Yvonne agreed to speak to pub manager Nik for her views after Jennie had notified her of the incident.

#### 11. SCHOOL PARKING - BUS PROBLEMS

Discussion took place once again about the issue of some parents parking without consideration for others, especially at school leaving times making it very difficult for bus drivers to pass the school traffic. This had resulted in some instances of the bus driver by-passing the village and continuing to drive down the Grane road. This has obviously caused inconvenience to passengers leaving the bus at The Pack walking along the overgrown footpath through fields carrying shopping etc, plus missing potential passengers waiting in the village for the bus.

# 12. MEMORIAL GARDEN - WILD FLOWER GARDEN SUGGESTION

Since the Memorial Garden is currently in a poor condition it had been suggested that a group be formed to turn it into a wild flower garden. After discussion it was agreed that whilst the idea of a wild-flower garden is good, it was felt that wild flowers, some consider them weeds, would be unsuitable for a memorial garden. Instead it was suggested that the Village Committee take over responsibility for the garden, a small group of green-fingered volunteers be formed to plant suitable flowers, shrubs and bulbs. Some money could be available from Village Committee funds to start the work together with cuttings and unwanted plants from villagers to save on costs.
